Also acquired Lillian's death certificate from the Commonwealth of Massachusetts. Sounds like she suffered a fractured skull and then died of cardiopulmonary arrest at Salem Hospital. The death certificate states that she never married, she had worked as a Housekeeper at Salem Hospital, her social security number

Made contact with the funeral home<sup>1</sup> that handled the burial of Lillian. From the Vital Statistics summary provided, we learn the following:

There was also a brief obituary printed in the Salem News (date unknown), stating:

“SALEM – Lillian M. Acey, 82, of 31 Oakland St., died Tuesday in Salem Hospital following a lengthy illness. She was born in Finland, daughter of the late Matti and Elizabeth (Bloom) Acey. She worked for 37 years with the former Danvers Bleachery and for 17 years with Salem Hospital. She is survived by one sister, Anna Kimball of Salem; two nieces, Joanna Davis of Lynn and Doris Knowles of Virginia, and several grandnieces and grandnephews. Her Funeral will be held Thursday at 2:30pm at Full Memorial, 84 Washington Square, Salem.”

Another tidbit learned from the Beverly City Clerk's office in 1988 was that “Helen Mowett & Lillian Acey lived at 44 Winthrop Ave. after Helen's husband died in 1963. Helen's name was omitted in 1975

*and then Lillian's also but I do not know if they moved way from Beverly, as I did not find any death records."*

*The author has been told that Lillian is buried with her parents though her name is not engraved on the tombstone.*

*Besides the information presented above, we also have some observations provided by her sister Anna Acey Kimball (letters to author 1989-1990).*

*"Lil never got married. She had one boy friend. He wanted to get married but she told him she wants to save some money before she got married. He was a pharmacist and went to California, met a girl and married her. Lil was broken hearted but she got over it. She never had a boyfriend before him never married nor had a boy friend after."*

*A BONANZA!!! In July 2002 received a large packet of information from INS regarding Lillian. Had requested what they had on file just hoping to get a copy of her original citizenship papers with a photo. It ends up that they also sent copies of Alien Registration forms and a bunch of other stuff. This is all summarized below with snippets from each document.*

*Alien Registration Form (AR-2), December 9, 1940*

*Name – Lillian Maria Acey*

*Entered US as – Lempi Maria Kujanpaa*

*Live at – 40 Walsh Ave., Peabody, Essec, MA*

*Born on – October 11, 1899, Uusikarlepy, Vaasan Laani, Finland*

*I am 5 feet 1 inches in height, weigh 175 pounds, have light brown hair and hazel eyes*

*I last arrived in the United States at New York, NY on February 26, 1900. I came in by S.S. Tinkwalla*


*My usual occupation is Textile Worker ... My employer is Danvers Bleachery, 119 Foster St., Peabody, MA, whose business is making cotton sheetings.*

*I am, or have been within the past 5 years, or intend to be engaged in the following activities: Textile Workers of America, C.I.O. affiliate*

*I have applied for first citizenship papers in the United States. Date of application = Sept. 1940. First citizenship papers not received.*

As a result of this paperwork, Lillian was issued an Alien Registration Card (AR-3) whose registration number was 4381480

Papers Filed, 1941

There is some paper work filed in 1941 which would lead credence to the claim of submitting paperwork in September 1940. These are a letter from the School Department, Peabody, Massachusetts dated June 13, 1941 and a translation of a Russian Passport, May 27, 1941.

According to the letter from the school "In reference to your inquiry as to proof of arrival prior to June 29, 1906 in the case of ACEY File Number 1X 80678, Miss Acey's school record would be the only documentary evidence available because of her youth. However I find from the registers that Miss Acey did not enter the Peabody Schools until September 14, 1908 although the records show that other brothers and sisters were enrolled, her late entrance being due to illness.

The family were known here as ACEY and the children entered school as such. The prospective declarant entered as LEMPI Acey but the first grade teacher immediately called her LILLIAN and she has been called it since. The father was naturalized in March 1933 at Lynn and established ACEY as the legal name, changing it from the original KUJANPAA, which had been difficult in American. My record shows no notation of change, but the declarant says it was made. See footnote (Admitted to Citizenship, Superior Court of Massachusetts, Lynn, March 23, 1933, Pet. No. 16650, MATTI ACEY, Certificate #3668110)

I have enclosed the passport and a translation which states that such passport was issued in January 1900 for a period of five years. Will this be acceptable as proof of arrival prior to June 19, 1906? May I call attention to the fact that the page translated was in Russian showing the declarant's name as LOMNI-MARIA but page one shows her name as spelled by the Finnish, LEMPI-MARIA.

Miss Acey will await your decision as to the value of the enclosed passport and translation, as evidence of arrival.

In certification of the above and for travel about freely this passport is given in the city of Nicholaystad, January 24, 1900.
